QSAR-ME Profiler beta version is provided with PaDEL-Descriptor version 2.21 software (<http://padel.nus.edu.sg>) for descriptors calculation and Toxtree version 3.1.0 software (<http://toxtree.sourceforge.net/>) for biotransformation most probable reactions detection. In this distribution, QSAR-ME Profiler beta version, Toxtree and PaDEL-Descriptor are separated entities: QSAR-ME Profiler beta version just calls PaDEL-Descriptor and Toxtree software as external tools, so none of the libraries provided within PaDEL-Descriptor folders are embedded within the executable (.jar file) of QSAR-ME Profiler beta version, so does not infringe the licenses of PaDEL-Descriptor, Toxtree and corresponding libraries (that are free software and can be redistributed: see, for details, the licenses in the corresponding folders).

In this distribution, for the user convenience, PaDEL-Descriptor and Toxtree software are provided as uncompressed folders already in the correct places. They are the original uncompressed files downloaded from the PaDEL-Descriptor and Toxtree websites.
